# From the Desk of The President

## WFCF Member, Mike May, Helps Raise Suicide Awareness

WFCF Member, Mike May, participated in the first annual 5K Walk for Suicide Awareness in Kaukauna, WI on September 11.

As a divorced father of two children, Mike understands the challenges facing other divorced dads ranging from financial and job stresses to the devastation of not being able to maintain a relationship with their children due to non-maximized placement schedules and conflict with the children's other parent.

Too many men succumb to the stress and sorrow and take their own lives. According to multiple studies, a divorced man is nine to eleven times more likely to commit suicide than a divorced woman causing suicide to be one of the top ten causes for death of men after divorce.

The goal of WFCF is to help men during the very difficult process of divorce and to let them know, "It gets better, don't give up, we're here for you and for your family." Mike's participation in the Walk for Suicide Awareness during a rainy Saturday in September sends the message to dads that they are not alone and that there are people who are fighting for them and their families no matter how dark the clouds may be.

## I sure hope the other dads are dorkier than me

I went to my daughter's dance recital recently, and I couldn't spot her on stage.

Claire's group took the stage as scheduled, but all I could see were tall, grown-up looking girls. No sign of my little Claire Bear.

So I did a second scan across the stage. That's when I saw her and realized she is one of those tall, grown-up looking girls. I don't know who did this, or when, but I would like to speak to whomever is responsible immediately.

At age 9, my daughter is on the verge of adolescence, a period more experienced parents tell me best appreciated from a distance, such as an ice cave in Antarctica.

Like any father, I am troubled by this. But I am trying to look on the bright side. She hasn't hit adolescence yet, which means Dad is still cool. Or at least, he isn't any less cool than he used to be.

Claire still snuggles up to me. She still listens when I talk. And she has yet to hide behind a tree rather than admit in public that I am her father.

I'm told that this golden time in the fatherdaughter relationship is about to run out, so I'm trying to savor it. Sort of like when you move into an apartment in the middle of the month and get Showtime free for a couple weeks.

I asked a couple of battle-tested fathers how long I have before things go bad, and the news isn't good.

My friend George said he officially became uncool—after a long, gradual slide from his previous status of hero—when his daughter started fifth grade. He went from a knight who could slay dragons to a guy whose every word and deed is a complete embarrassment, sort of like Mel Gibson.

"As the dad, you are cast as a humorless, inept, unreasonable dictator who needlessly grills the child with torturous questions such as, 'What did you do in school today?' 'Who called?' and 'What?' (when you didn't hear the question the first time)." George sade. "By the way, the answers to those questions invariably are 'Nothing,' 'Nobody,' and 'Nevermind.'"

Those are hardly comforting words. Things didn't get much better when I consulted my father. His theory is that trouble strikes at puberty, when females feel a biological imperative to identify potential mates and reject Dad.

Surviving this phase requires luck, Dad said. First you hope to have a daughter who is kind of forgiving of your dorkiness. Second, you hope her friends' fathers are dorkier than you are.

"If the fathers of your daughter's friends are control freaks or otherwise embarrassing nut jobs, you have a chance to look good by comparison," Dad said. "Then her friends will be telling her that she's lucky she doesn't have a father like theirs. And her friends will be nice to you because you're not as wacky as their own dads. When your daughters sees them being nice to you, she'll follow suit."

In the meantime, he advises setting the bar low. In other words, I should try to be a little less cool now, so that my inevitable fall from grace won't seem so precipitous.

"In your few remaining days flying under the coolness radar, it's important to work on not being cool. Never do anything that might be cool. If you're not sure, and you might end up doing something cool, do it incorrectly, " Dad said. "The secret is to get the standard so low that a corpse could meet it."

My buddy George tried to cheer me up with this advice for a father whose daughter hasn't yet holed up in her cocoon of adolescence:

"Treasure the time when she still wants to hold your hand walking down the street, or sit on your lap to read a book or watch TV." George said. "No matter what stage of life they're in , take comfort in knowing that – despite what they say or dothey always love you and they will always be your little girl."

Even when they're hiding behind a tree and pretending you're a perfect stranger.

I will not encourage or be part of the squabble that so readily flows from the argument over He vs. She or Man vs. Woman. I am disgusted by the idea that men were once permitted to do harm to women and this was justified by the law because he "owned her" and that women are now permitted to do harm to men and this too is justified by the law because she "owes him." Her bad behavior is not only defensible but often celebrated because he had an affair and deserves what he got. This purest form of mediocrity is leading us right down the path of stupidly repeating our own history with the only goal in sight being to remain stuck within the trenches of vilifying one another. Are we not capable of seeing the big picture here?

How quickly we forget that women were once faced with the public terror of rejection by both sexes for having been accused of the crimes of love and passion, a.k.a., adultery. While not condoning these activities as justifiable they carry with them enough shame and pain to last all parties a lifetime without having to heap loads of our own covert guilt and remorse onto others difficult choices as a means of avoiding the truth within ourselves and the ugliness of this deep gash in our social and cultural history.

Who are we to judge? Why do we see ourselves as so angelic and justified in our own perfection that we can't imagine ever being faced with such heart wrenching choices ourselves? If you deem yourself immune you have not considered a perspective outside of your current one, think harder and then consider honestly that you are imperfect and can be pushed to reach the limits of your own human capacity. It is not possible for any of us to be certain of our choices in extreme situations until we have ourselves been exposed to the circumstances that take us there. We can only imagine what we would do for survival if stripped of our comforts and necessities to thrive. If left for dead we would find ourselves capable of the unthinkable. Hollywood has graced us with scenes of plane crash victims surviving on the flesh of their friends and pushed our imagination to the limits of what we will do if our desperation for survival becomes great enough.

Who are we I invite you to consider. Do we really think is conceivable to deny ourselves just about any measure of comfort or chance for survival no matter the risk in the face of death?

Facing death extends psychologically to the rage we feel when we learn that a loved one has betrayed us and murdered the life of the very thing we have given ourselves and lives to, our relationship. Intimacy is at its core our most worthy of needs. We seek this fulfillment in different ways but we must feel as though we belong to something and to someone, our very survival depends on it. Our souls plead for revenge in the face of its impending destruction. In this terror and confusion we forget that we are not wild tigers charged with protecting the pride, yet we often react as though we are.

Women who discover the infidelity of a partner often immediately lash out in revenge and rage, pulling their children behind them, speaking harshly of their protector, making ever attempt to harm the one who has caused them such pain by wallowing in their misery. In defense of their pride

they justify their actions and the harm they do to their children under the guise of protecting them when nothing could be further from the truth. ## Response to Miguel Morga's letter:

Written in response to Child Support work Miguel Morga's letter published in Today's Dads (Volume 21, Number 4)

I read with great interest the letter published in last month's "Today's Dad" periodical and thank the writer for the time and effort made in both reading the newsletter and fashioning an eloquent summary of his experience as Child Support Investigator for Crawford County. I do have several comments to make that might explain how and why non-custodial parents (NCPs) perceive him and others like him and thus might act in an "immature fashion" and have a "negative stereotype" of people who do his job.

By the time the NCP first deals with a child support investigator, he/ she has already been put through the ringer over months and sometime years dealing with and paying for agents of "Family" court. This includes but is not limited to psychologists, mediators, family court counselors, guardians-ad-litem, social workers and custody evaluators. These agents would have already poked and prodded their way through every nook and cranny of their lives. These same people would have made reports and recommendations to the court regarding who gets to be the custodial parent.

These third-party "experts" would have made assumptions and allowed their own personal biases to enter into one of the most important decisions one can have in their lives. These people would have made these decisions behind closed doors and the NCP would have been given no good reason why they cannot see their children and least 50% of the time despite legislation passed in 2000 that clearly states that "Family" court must choose the parenting plan that maximizes contact with BOTH parents.

Months and even years can go by and the NCP will quickly learn that he/ she has no control over their children and will have been relegated to a visitor status in the lives of their children despite the fact that they have done absolutely nothing wrong. They will quickly learn that if the winner parent alienates their kids against them, those same government agents will do nothing. They quickly learn that if the winner parent doesn't want the loser parent to see their kids, there is very little they can do.

I can say from my own personal experience in dealing with Racine County Family Court that I had to call my State Legislator on two occasions

before I was allowed to see my child. Only when she called the courthouse did my attorney finally get an immediate hearing and access to my child. In addition, I had to wave goodbye as mom moved to Illinois despite my rigorous objection and continued to restrict my visitation and continued to poison my relationship with my daughter.

All of this despite legislative efforts to stop it. Meantime, government workers like Mr. Miguel go about their jobs completely oblivious to the harm they are doing by "looking the other way", and just "doing their jobs". The vast majority of NCPs would love to be equal partners in the parenting of their kids. They would do a fine job in well over 80% of the time.

If there were shared parenting by default, there would be no need for 80% of the people like Mr. Miguel who feed from both government and parent's troughs and restrict or chase away well meaning parents who have done nothing wrong.
