

# **Arguing for Equal Shared Placement in Wisconsin**

# **Understanding Wisconsin's Placement Laws**

**Wisconsin does not have a statutory presumption for equal placement**, but the state's law requires courts to maximize the time children spend with both parents when it serves the child's best interests [1]. The court must create a placement schedule that provides "regularly occurring meaningful periods of physical placement with each parent" and "maximizes the amount of time the child may spend with each parent" [2].

## **Key Legal Framework**

#### **Shared Placement Definition**

In Wisconsin, **shared placement** occurs when each parent has the child for at least 25% of the time annually (approximately 92 overnights or more) [3] [4]. This threshold is significant because it affects child support calculations and recognizes both parents as actively involved in the child's life.

# **Court's Primary Consideration**

All placement decisions must serve the **best interest of the child** [5]. Wisconsin statute section 767.41(5) requires courts to consider sixteen specific factors when determining placement arrangements [6].

- Document the amount and quality of time you've spent with the child [7]

- Demonstrate your availability and ability to care for the child independently [8]
- Show you can manage logistics like school transportation, work schedules, and childcare [8]
- Present a realistic parenting plan that addresses daily routines [1]

# 4. Stability and Continuity

- Prove you can provide a stable environment [8]
- Show how equal placement would maintain or improve the child's adjustment to home, school, and community [2]
- Address any necessary lifestyle changes you're willing to make to maximize placement time

# **Strategic Documentation**

#### **Communication Records**

- Keep detailed logs of all communications with the other parent [9]
- Document instances of cooperation or lack thereof [5]
- Record attempts to involve the other parent in decision-making [6]

### **Professional Support**

- Obtain recommendations from teachers, doctors, therapists, or other professionals who can speak to your parenting abilities [9]
- Consider involving a Guardian ad Litem who can advocate for the child's best interests [2]

#### **Detailed Parenting Plan**

Rather than simply requesting "50/50 placement," present a comprehensive parenting plan that addresses [1]:

- Specific daily and weekly schedules
- Holiday and vacation arrangements
- Transportation logistics
- Decision-making protocols
- Emergency procedures

# **Addressing Common Challenges**

#### **Geographic Considerations**

Courts must consider the practical aspects of shared placement, including:

- Distance between parental homes [10]
- Impact on the child's school attendance and activities [7]
- Transportation arrangements and costs [6]

# Child's Age and Developmental Needs

- Younger children may need more stability and routine [10]
- School-age children require consideration of educational consistency [7]
- The child's own wishes (communicated through appropriate channels) will be considered [5]

#### **Modification Considerations**

If you're seeking to modify an existing placement order, remember that **Wisconsin courts** generally cannot modify placement within the first two years unless there's evidence of physical or emotional harm or both parents agree to the change [11].

# **What Equal Placement Looks Like**

Equal shared placement can take various forms [10]:

- Alternating weeks: Child spends one week with each parent
- 2-2-3 schedule: Two days with one parent, two with the other, then three days alternating
- Split schedules: Different arrangements for school year versus summer
- Custom arrangements: Tailored to family's specific needs and circumstances

# **Financial Implications**

Equal shared placement affects child support calculations through Wisconsin's **shared placement guidelines** [4]. When both parents have at least 25% placement time, support is calculated based on both parents' incomes and their respective placement percentages [12].

# **Mediation Requirement**

Wisconsin law **requires mediation** for contested custody and placement cases before proceeding to trial [3]. This provides an opportunity to negotiate a mutually acceptable arrangement and may increase the likelihood of achieving shared placement [13].
