AB897 was passed by the Family Law Committee by a vote of 4 Ayes and 2 Noes and by the entire Assembly by a vote of 60 Ayes and 35 Noes, but was never voted on in Committee in the Senate:

Re-introduce as AB571 and SB 311:(The statutory references were changes in light of restructuring of the statutes, however the content remained the same.)

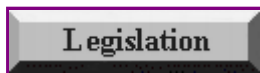

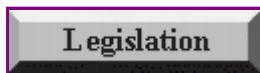
